Board of Directors Meeting Minutes March 14, 2015

The Breakwater Estates board of Directors met at the home of Board President Maryl Kerley on Saturday, March 14, 2015. Present at the meeting were: Brian Eichenlaub, Maryl Kerley, Karen McGavin, Scott Standiford, Doris Walsh, Grace Gannon and Frank Frazzano from the board. Also attending was Jennifer Fannin, Property Manager from Sea Scape.

President Maryl Kerley called the meeting to order at 9:10 am.

Minutes of the November 7, 2014 Meeting

Grace Gannon presented and the minutes (Brian Eichenlaub, Secretary, was not able to attend) and they were read by all with no corrections suggested. Grace Gannon made a motion to accept the minutes as presented and Karen McGavin seconded. The motion carried.

Minutes of the May 17, 2014 Meeting

Brian Eichenlaub presented and the minutes and they were read by all with no corrections suggested. Doris Walsh made a motion to accept the minutes as presented and Brian Eichenlaub seconded. The motion carried.

Treasure's Report

Doris Walsh, BWE Treasure, presented the treasure's report. The community has \$35,878.83 in the Community Bank CD, \$4,881.08 in the Community Bank Checking Account and \$57,972.05 in the two other Community Bank CD's and \$\$24,134.62 in the Community Bank Road Reserve Funds account for a total of \$122,866.58

We were under budget this year for snow removal. There were only two snow events this winter as opposed to six last year. This saved the community \$500.00 in snow removal costs.

Budget Discussion – Board decided to keep association dues at \$480.00 per home. This is the same amount as last year.

Three homeowners have overdue expenses – Not many homeowners and they are less than 30 days overdue.

Property Managers Report: Jennifer Fannin from SeaScape presented the Property Managers Report.

- 1. A house is in foreclosure and landscaping needs to be done. \$35.00/visit or about \$90.00/month. Accepted contract. All agreed
- 2. The "No Parking" sign at Breakwater Drive and Rusty Anchor is missing. It was agreed not to replace the sign and to have the remaining pole removed. It was probably damaged during snow removal.
- 3. A sewer top that was missing was found and put back in place at Beacon and Lighthouse Drives. Perhaps a snow plow knocked it off when plowing due to a dip in the road at this location. Cold patch will be used to fill the dip and cracks which were missed last summer will be also filled this spring.

Old Business

• School Buses in BWE

- \blacktriangleright All OK with busses.
- Trash trucks are still a problem. It was observed that Waste Management trucks were still is cutting through on Fridays. House at 21 Lighthouse Drive and 5 Beacon still uses Waste Management. Ms. Fannin will contact owners and let them know that we use Waste Industries only.

• Signatories on Bank Accounts – Send approved November minutes to the Bank

Checks for Deposit – Ms. Fannin could deposit checks if Grace Gannon or Doris Walsh is not available to deposit checks. We should have another board member able to sign and deposit checks. No decision was made as to which member.

• Status of Verizon lines on Beacon Drive

- Ms. Fannin wrote a letter to Verizon regarding the wire crossing five homes on Beacon Drive. It has been almost a year since the wire was installed and repeated phone calls and letters have not been successful.
- Ms. Fannin will ask the five home owners to individually call and write letters to Verizon and also call Verizon's Customer Retention Office.
- Pete Schwartzkopf, the District 14 state representative in Dover, will also be contacted to see if he could intervene and help.

• Storage of Records

- Community Bank charges \$125/year for a 10" x 10" safety deposit box. That is not big enough to hold the community records and important incorporation documents.
- > Will check with other banks, perhaps, main branches.
- Frank Frazzano will check with our law firm to see if they could store the community records or have suggestions as to where they could be safely stored.
