Board of Directors Executive Session Transition Meeting Minutes Saturday, July 25, 2015 9:00 am

Outgoing President Maryl Kerley called the meeting to order at 9:05 am.

This meeting was called by Maryl Kerley as a special session transition meeting and to come to an agreement on a new President of the Board.

Also, at the community meeting of June 6, 2015, volunteers were asked if anyone would like to come forward and fill the vacancy left by Maryl. No one at the meeting came forward. - Maryl still has the community 2007 QuickBooks disks for accounting purposes. It has not been used in years. It is out of date and the board decided to trash it. Also, SeaScape, who now does the community books, uses the latest QuickBooks online and has no use for it.
- For years, Maryl has housed the yard sale signs. Who will now do it? MJ volunteered to house them in her shed.
- The new homeowner at 2 Breakwater Drive have erected a satellite dish at the front of their property very much near the Breakwater Estates entrance sign on Munchy Branch Road. Discussion occurred that it need to be moved into the back because of BWE covens. The satellite dish rules are outdated and unenforceable and Federal law allows them; thus superseding BWE rules. When an amendment is written, Scott Standiford should be the one to do this since he is an expert in this area.

- There are several renters in the neighborhood. Should a copy of the lease be given to the HOA? They are not now required to do so, and maybe they should. Something for the future Board and community to think about.
