

Board of Directors Meeting Minutes Special Meeting Saturday, November 11, 2017 9:00 am

The Breakwater Estates Board of Directors met at the home of Board Treasurer MJ Melah on Saturday, November 11, 2017. Present at the meeting were Board members: Brian Eichenlaub, Doris Walsh, Lana Warfield, MJ Melah, Grace Gannon, and Mike Forry. Absent: Karen McGavin

This special meeting was called due to a letter the Board received dated October 19, 2017 from SeaScape informing our community of their intent not to renew our property management agreement for 2018. Three bids were solicited from area property management companies since receiving that letter and this meeting was to pick a new property management company.

New Business

Selection of New Property Management Company

The meeting went immediately into new business at hand – that of reviewing the three property management companies proposals.

The three companies submitting bids were:

Legum/Normon, Inc.
Right Property Management
HPS Management (formally Guardian and also BWE former management company)

Discussion occurred freely with each proposal reviewed. Service, support of current software (QuickBooks), website, and costs were all reviewed. After lengthy discussion, an informal vote was held and HPS was selected based on their services offered weighed with their cost to the community. MJ Melah moved to have HPS Management, located at 17298 Coastal Highway, Unit 1, Lewes, DE 19958 be the new BWE property management company for 2018. Brian Eichenlaub seconded and all agreed.

MJ Melah, Doris Walsh and Grace Gannon all agree to meet the following week with our new community representative and work out transition details.

Open Discussion – Updates since the last meeting on September 16, 2017

Late Payments – Four more residents are behind in community payments for a total of nine at this date. Will find out what HPS policy is and what they may suggest with late payments and fees.

Community CDs – Community CDs were renewed by MJ Melah.

Roads – A crack and seal bid came in from Performance Seal Coating for \$2500. Working on obtaining a third bid.

NEW BWE Website – Testing and vetting has occurred and we would like to launch the new BWE website ASAP. We think it is a huge improvement and great! A very big thank you needs to go to Mike Forry and MJ Melah for all of their hard work in designing the new site. Mike and MJ have agreed to also update the site and keep it current.

Brian is writing a letter to go out to the community announcing the site and inviting all of the community to check it out. He will do it in the next few days. (Attached).

Next Meeting – The next Board meeting will be on Saturday, December 9, 2017 at Grace Gannon's home at 9:00 am.

Meeting adjourned at 11:00 am – Lana Warfield moved to adjourn and MJ Melah seconded. All approved.
