

Call of Order

Approval of Minutes

Motion made to approve the minutes from 10/13/18 by Doris Walsh, seconded by MJ Melah and unanimously approved as presented with noted date change.

Motion made to approve the minutes from 7/14/18 by MJ Melah, seconded by Grace Gannon and unanimously approved as presented.

Treasure's Report

A motion was made to move \$80,000 from the Reserve Fund to a higher interest Money Market account by Brian Eichenlaub and seconded by MJ Melah, unanimously approved.

Kelly Quinn to provide the collection rate sheet received by Whiteford Taylor and Preston to the Board for consideration.

Kelly Quinn provided the revised balance sheet with the beautification fund set up under liabilities, coming out of retained earnings. Currently this fund has \$500, when year-end closes, it will increase to \$750.

Old Business

Kelly Quinn to find out the owner of 3 Breakwater and provide to Board.

Lana Warfield is working on proposed bylaw amendment. Kelly Quinn and Brian Eichenlaub will work with Lana on cover letter and ballot. Need to verify the percent of homeowners needed to pass the bylaw amendment.

New Business

Kelly Quinn to get a price for repairing the pot hole at 3 Beacon.

Kelly Quinn to work on and email blast to all Owners reminding them to pick up after their pets, check houses, blow lawn clippings, pull trash cans up, and so on.


Meeting adjourned at 1:16 pm – Brian Eichenlaub moved to adjourn and Mike Forry seconded. All approved.
